**Staff.**

I hereby thank the staff members in this period of covid for having persevered and helped the children academically, socially and spiritually. Our home has continued in all circumstances.

**Administration.**

I do thank the lord for that guide. To the children on family support have been supervised and monitored. Some feel sick and we tried to support medically too. Shared with them some food stuffs. Let me thank you for that support.

The Government Curriculum due to covid 19 was not followed and all the schools went on lockdown, the official opening is not known to us, however the candidate children thus primary 7, senior 4, senior 6 final at the University and Tertiary Institutions were allowed to reopen awaiting for their final examinations. Another challenge after the Lockdown is the termination of the employment contracts for many people are now jobless including the grown up children.

**Health.**

We have been faced with different sickness within the staff members. We thank the good Lord for the children are not affected though some have malaria but it was mild. Through JET we have continued to be visited and trained first aid in Health Care.

**Visitors.**

In this epidemic, visitor have been restricted from coming, we were meant to receive visitors from Belgium but their trip were cancelled on the last minute. We want to appreciate the Roke Telekom Company and U.C.U students who visited the children briefly. We also appreciate the Indian Community that have kept coming to check on the children. We also appreciate all the people who have continued to support Mama Jane Family even during this period. thank you so much.

### Projects.

The Vocational Construction is done and await finishing and stage 1 opening. However we are hit with the present situation. Secondly is the tutors to train the students. All this will depend on the Government reopening of the school programme.

Too, the meetings have not been held too due to the Lockdown/ SOPs, The other internal projects have been maintained and skill have been passed to the children. I am proud to write that during this covid19 we have directly studied the children and empowered them with skills and bible sharing and leadership plus self esteem.

On the side of the garden, the food have been greatly helpful because we managed to get fresh foods from the garden.

We planted maize, cassava, potatoes, and bananas though due to transport, the children have not participated fully, so we hired some people to help us.

### Livestock.

I am happy to report that the cows produced 3 calves, 2 cows and 1 bull. One cow was sold off to get better breed.

### Challenges.

1. Covid 19 threats and proper vaccination for it because its spreading fast.
2. Start off kits have remained a challenge this ending year more so when the children are unemployed.
3. Furnishing the Vocational Training Institute.
4. Land titles for our pieces of land.
5. Funds for the continued running of the a fore mentioned projects.
6. High cost of living yet the economy is low.
7. Transport is still a big problem especially during supervision and monitoring of the children on Family Support.
8. Low pay for the staff since this demotivates them.

### Achievements.

1. Feeding the children on a balanced diet and they are all healthy.
2. Salaries have been paid.
3. Working relationship with the different partners has been maintained.
4. All utility bills have been cleared.
5. Completion of phase one of the Vocational Structure.
